Ms. Parker:

This is an official COMPLAINT regarding the UNLAWFUL approval of Agenda items at the SPECIAL CONCURRENT meeting of the Oakland Redevelopment Successor Agency/City Council on Monday December 18, 2017. These Agenda items NEVER appeared before the appropriate Standing Committee prior to the Council's approval at the Special meeting on December 18, 2017.

Pursuant to Government Code 54956(a) "A Special meeting may be called at any time by the presiding officer of the legislative body of a local agency, or by a majority of the members of the legislative body"..."No other business shall be considered at these meetings by the legislative body."

NOTE: It is unknown who initiated the action for the Special meeting of December 18, 2017, whether it was called by the President of the Council, Larry Reid or by a majority of the members of the Oakland City Council. Councilmember Desly Brooks was not present at the meeting.

Government Code 54954.3(a) requires "Every agenda for the regular meetings shall provide an opportunity for member(s) of the public to directly address the legislative body on any item of interest to the public, before or during the legislative body consideration of the item"... Further,

"Every notice for a Special meeting shall provide an opportunity for members of the public to directly address the legislative body concerning any item that has been described in the notice for the meeting before or during consideration of that item." (b)(1) The legislative body of a local agency may adopt REASONABLE regulations to ensure that the INTENT of subdivision(a) is carried out, including, but not limited to, regulations limiting the total amount of time allocated for public testimony on particular issues and for each individual speaker. Here is where President Larry Reid has abused his discretion and has violated the INTENT of Government Code 54954.3(b)(1). by directing the City Clerk to limit the time of each speaker to a maximum of six minutes although some members of the public wanted to comment on All of the Agenda items listed on the Consent calendar which totaled 21 items

THE ISSUE; What is considered "REASONABLE"

It should be noted that the President of the Council purposely 'bundles' an UNREASONABLE" number of items for the CONSENT calendar to limited public comments without staff presenting a report before Council approval on the BUNDLED items

While the Special meeting of the Oakland City was lawful under Government Code 54956; the Council's approval action of twenty-four (24) agenda appearing both on the CONSENT and the NON-CONSENT appears to have been UNLAWFUL under Government Code 54954 (3)(a) and (b)(1).

There were twenty-one(21) agenda items listed on the CONSENT calendar and three(3) agenda items listed on NON-CONSENT. It should be noted that all of the above items were scheduled for the appropriate Standing Council Committee meetings that were NEVER without staff's recommendation held prior to the Council's approval action at the Special meeting of December 18, 2017. The most egregious action by the Council was Agenda item 13 appearing on the NON-CONSENT calendar that was scheduled for the Public Works Standing Committee, but was never held. The item(Project No. G121810) regarding Replacement of Embarcadero Bridge Channel-which is increasing the CHANGE ORDER for the contract with Flatiron West Inc. from twenty-five(25%)percent to Eighty Percent(80%)percent. Although, a staff report was given(very sketchy at best) ,accompanied by the ill-advised comments by the City Attorney stating that, "Because Oakland is a Chartered City they can established their own rules." NOTE: This increase in the long established CHANGE ORDER percentage was highly irregular which is almost doubling the so-called "lowest responsible"
